Mr. Conley presented to the Board for their initial consideration school board policy updates to section 2. The policy changes/updates will be brought to the Board in April for their approval.

Lori Tilden-Geiger and Tania Grimes provided the Board information on TVSC being named a #GoOpen Launch District by the United States Department of Education and the Indiana Department of Education. This initiative will allow TVSC to use Open Educational Resources instead of the traditional textbook.

Lori Tilden-Geiger provided an update on the Innovation Planning Grant that was awarded to TVSC in December 2018. This grant will allow TVSC to plan for future integration of technology into teaching and student learning. The first phase of this grant process took place when the team provided a self-assessment. TVSC is now moving into the second phase which includes an infrastructure audit and a survey which will be completed by parents, staff and students.

Mr. Shriver presented to the Board a proposal to offer the classroom portion of driver's education during summer school. TVSC has not offered the classroom portion recently due to online alternatives available. Todd Hoffman made the motion to approve the summer driver's education class and Aaron Zolman seconded the motion. The motion carried unanimously.

Mrs. Mills, Mr. Backus, and Mr. Cripe presented changes to student and staff handbooks for initial consideration. Final approval of the handbook changes from the Board will be obtained in April.

Mr. Backus presented to the Board information regarding the Tippecanoe Valley Angler's Club. This club would be available to middle school and high school starting this spring. A point system will be used to determine the top anglers at TVSC. The top anglers will represent TVSC at the Student Anger Foundation's fishing tournaments in the spring and summer in northern Indiana.
